

SUMMARY ANNUAL REPORTS

Lattice Engines, Inc. 401(k) Plan

This is a summary of the annual report for Lattice Engines, Inc. 401(k) Plan, Employer Identification Number 20-4504228, Plan No. 002 for the period January 01, 2019 through December 31, 2019. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses were \$870,467. These expenses included \$14,847 in administrative expenses and \$847,586 in benefits paid to participants and beneficiaries and \$8,034 in other expenses. A total of 161 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$6,804,158, as of December 31, 2019 compared to \$5,177,428 as of January 01, 2019. During the plan year, the plan experienced an increase in its net assets of \$1,626,730. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$2,497,197, including employer contributions of \$2,411, employee contributions of \$1,184,947, other contributions of \$14,321, and earnings from investments of \$1,295,518.

The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Lattice Engines, Inc. has committed itself to pay certain healthcare FSA (medical, dental, vision) claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with California Physicians Service, Vision Service Plan, Kaiser Foundation Health Plan Inc., Metropolitan Life Insurance Company and The Lincoln National Life Insurance Company to pay certain medical, life, accidental death & dismemberment, dental, vision, temporary disability, long-term disability and employee assistance program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2019 were \$1,766,560.
