

SUMMARY ANNUAL REPORTS

The Dun & Bradstreet Corporation 401(k) Plan

This is a summary of the annual report for The Dun & Bradstreet Corporation 401(k) Plan EIN 22-3725387, Plan No. 002 for the plan year January 1, 2021 through December 31, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by a trust fund. Plan expenses were \$120,852,042. These expenses included \$210,812 in administrative expenses and \$120,490,963 in benefits paid to participants and beneficiaries, and \$150,267 in certain deemed and/or corrective distributions. A total of 5,195 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$1,309,824,715 as of the end of the plan year, compared to \$1,205,658,370 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$104,166,345. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$225,018,387, including employer contributions of \$10,735,627, employee contributions of \$33,678,546, other contributions/other income of \$3,781,180, and earnings from investments of \$176,823,034.

The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Dun & Bradstreet Corporation has committed itself to pay certain claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with ARAG Insurance Company, Securian Life Insurance Company and Unum Life Insurance Company Of America to pay certain Legal, Life Insurance and Long-Term Disability claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2021 were \$2,142,397.
